NOTES ON DATA PROTECTION

The following privacy policy applies to the website available at www.pm-international.com and to the processing of your personal data as a customer or Team Partner of PM-International.

The protection of your personal data and your privacy are important to us.

For this reason, we would like to explain below what PM-International does to do justice to you and us in this respect. We would like to explain what personal data we collect, how we use it and how we protect your data. You will also find out who we will pass this data on to and how you can have your data changed. PM-International’s data protection policy is in accordance with the applicable legal provisions of the local applicable law and the provisions of the Singapore Personal Data Protection Act 2012 (“PDPA”). This data privacy policy explains which data is stored by PM-International and how it is used.

DURATION FOR WHICH THE PERSONAL DATA IS STORED:

We store your data,

- if you have consented to the processing, at most until you withdraw your consent,
- if we require the data for the performance of a contract, at most for as long as the contractual relationship with you exists or statutory retention periods apply,
- if we use the data on the basis of a legitimate interest, at most as long as your interest in deletion or anonymization does not prevail.

DATA SOURCES

We receive the data from you (including about the devices you use).

DATA TRANSFER TO THIRD COUNTRIES

Data is transferred to third countries outside of Singapore. This takes place on the basis of contractual regulations provided for by law, which are intended to ensure adequate protection of your data and which you can view on request.

RIGHT OF ACCESS, RECTIFICATION OR ERASURE OR RESTRICTION OF PROCESSING OR THE RIGHT TO OBJECT TO PROCESSING AND THE RIGHT TO DATA PORTABILITY:

You have the right,

第三方的数据处理

如果PM-International在销售管理的过程中将数据传递给服务提供商(例如快递服务提供商、支付服务提供商等), PM-International会在每种情况下签订订单处理合同。因此, 销售伙伴不仅依法受数据保护的约束, 还与PM-International签订合同, 承担数据保护的义务。

个人数据和与交易相关的数据根据欧盟委员会定义的“欧盟标准合同条款”进行转移。

商品订单、个人用户资料的数据保护

在订购商品时, PM-International 会收集客户的个人数据, 以便处理和履行订单。以下客户数据被收集、存储和使用: 姓名、地址、电子邮件地址、出生日期、电话号码、支付信息, 以及在通过直接借记付款的情况下, 账户详细信息, 如适用, 还包括信用卡支付的其他银行信息。您在此提供的信息仅用于简化您的订单处理流程、行政管理以及内部分析。本次处理您个人数据的法律依据为《通用数据保护条例》第6条第1款第1句b)项, 并为履行与您签订的合同或执行您要求的必要的合同前措施而进行。

我们从 Personal Data Protection Commission (PDPC) 获取信息以验证您的地址(检查可送达性)。

REQUIREMENT OR OBLIGATION TO PROVIDE DATA

Unless expressly stated at the time of collection, the provision of data is not required or mandatory..

DATA PROCESSING BY THIRD PARTIES

If PM-International passes on data to service providers (such as parcel service providers, payment service providers, etc.) in the context of sales management, PM-International concludes order processing contracts in each case. As a result, sales partners are not only bound to data protection by law, but also by contract with PM-International.

Personal and transaction-related data is transferred in accordance with the “EU standard contractual clauses” defined by the EU Commission.

DATA PROTECTION FOR GOODS ORDERS, PERSONAL USER PROFILES

When ordering goods, PM-International collects personal data from customers in order to process and fulfill the order. The following customer data is collected, stored and used: Name, address, e-mail address, date of birth, telephone number, payment information and, in the case of payment by direct debit, the account details information and, if applicable, further bank details for credit card payments. The information you provide here is used exclusively to simplify your order process, for administrative purposes and for internal analysis. The legal basis for this processing of your personal data is carried out for the purpose of fulfilling a contract concluded with you or for carrying out necessary, pre-contractual measures that are carried out at your request.

We obtain information to verify your address (check for deliverability) from Personal Data Protection Commission (PDPC).

为此,我们将必要的数据(您的全名、您的地址以及(如果适用)您的出生日期)传输给上述公司。未来该公司还将利用这些数据与其他公司进行地址验证或身份核查,并用于相应的评分应用。评分根据数学统计程序计算某些未来行为的概率值,并为此目的使用相应的数据。

我们还将数据传输给 Credit Bureau (Singapore) Pte Ltd (CBS) 进行信用检查。

Credit Bureau (Singapore) Pte Ltd (CBS) 进行信用检查。它运营着一个数据库,在该数据库中存储着关于个人信用状况的信息。在此基础上,Credit Bureau (Singapore) Pte Ltd (CBS) 向其客户提供信用报告。客户包括信贷机构、租赁公司、保险公司、电信公司、应收账款管理公司、邮购公司、批发和零售公司以及其他提供商品或服务的企业。根据法律要求,信息数据库中的部分数据还被用于为其他公司数据库提供数据,包括用于地址交易目的。

以 Personal Data Protection Commission (PDPC) 的数据库中,特别存储有关个人的姓名、地址、出生日期、电子邮件地址(如适用)、支付历史和所有权结构的信息。存储数据处理的目的是提供有关相关人员信用状况的信息。处理的法律依据是欧盟 GDPR (EU) 2016 第 6 条第 1 款第 1 句 f) 679,根据该条款,只有当客户能够可信地证明自己具有合法的知情利益时,方可提供关于这些数据的信息。如果数据转移到欧盟以外的国家,这是基于所谓的“标准合同条款”进行的。

数据将被存储至完成存储目的所必需的时间为止。一般情况下,初始存储期限为三年。到期后,将检查是否仍然需要存储,否则数据将按日删除。如果事务已解决,数据将在解决后三年内按日删除。

在 PDPA 第15条所指的合法利益(即视为您已同意)可能包括:信贷决策、业务启动、投资关系、索赔、信用评估以及执法信息。

For this purpose, we transmit the necessary data (your full name, your address and, if applicable, your date of birth) to the aforementioned company. In future, this company will also use this data for the purposes of address verification or identity checks with other companies and for corresponding scoring applications. Scoring calculates probability values for certain future behavior based on mathematical-statistical procedures and uses the corresponding data for this purpose.

We also transmit data to Credit Bureau (Singapore) Pte Ltd (CBS) for credit checks.

Credit Bureau (Singapore) Pte Ltd (CBS) is a consumer credit agency. It operates a database in which creditworthiness information about private individuals is stored. On this basis, Credit Bureau (Singapore) Pte Ltd (CBS) issues credit reports to its customers. Customers include, for example, credit institutions, leasing companies, insurance companies, telecommunications companies, receivables management companies, mail order, wholesale and retail companies and other companies that supply goods or services. In accordance with legal requirements, some of the data in the information database is also used to supply other company databases, including for address trading purposes.

In the Personal Data Protection Commission (PDPC) database, information is stored in particular about the name, address, date of birth, e-mail address if applicable, payment history and ownership structure of persons. The purpose of processing the stored data is to provide information on the creditworthiness of the person in question. The legal basis for the processing is Section 15 of the PDPA (i.e. deemed consent from you), according to which information about this data may only be provided if a customer can credibly demonstrate a legitimate interest in knowing this information. If data is transferred to countries outside the EU, this is done on the basis of the so-called “standard contractual clauses”.

The data is stored as long as necessary to fulfill the purpose for which it was stored. As a rule, knowledge is required for an initial storage period of three years. After expiry, it is checked whether storage is still necessary, otherwise the data is deleted to the day. If a matter is settled, the data is deleted to the day three years after settlement.

Legitimate interests within the meaning of Section 15 of the PDPA (i.e. deemed consent from you) may be: credit decision, business initiation, investment relationships, claims, credit assessment, enforcement information.

您有权从 Personal Data Protection Commission (PDPC) 获取关于您个人数据存储情况的信息。如果存储的关于您的数据不正确,您有权要求更正或删除。如果无法立即确定数据是错误还是正确,您有权在澄清之前暂时封锁相关数据。如果您的数据不完整,您可以要求补充完整。

如果您同意 Personal Data Protection Commission (PDPC) 处理存储的数据,您有权随时撤回此同意。撤回不会影响在撤回之前基于您同意进行的数据处理的合法性。

如果您有任何关于数据保护的异议、请求或投诉,您可以随时联系 Personal Data Protection Commission (PDPC) 的数据保护官。他将在所有与数据保护相关的事项中,快速且保密地为您提供帮助。您还可以向负责您所在联邦州的数据保护官投诉 Personal Data Protection Commission (PDPC) 的数据处理。

服务提供商名称的数据 Credit Bureau (Singapore) Pte Ltd (CBS) 存储的关于您的数据来源于公开可访问的来源、债务催收机构以及它们的客户。为了描述您的信用状况, Credit Bureau (Singapore) Pte Ltd (CBS) 会为您的数据计算一个评分。评分值包括年龄和性别数据、地址数据以及在某些情况下的支付经验数据。这些数据在评分计算中被纳入,并采用了不同的权重。Credit Bureau (Singapore) Pte Ltd (CBS) 客户在做出自己的信贷决策时,会将评分值作为参考。

异议权:

服务提供商名称存储的数据 Credit Bureau (Singapore) Pte Ltd (CBS) 出于债权人和信用保护的正当合理理由而进行处理的,这些理由通常优先于您的利益、权利和自由,或用于主张、行使或维护法律权利。您只能基于自身特定情况提出数据处理的异议,并且必须提供相应的证明。如果能够证明存在此类特殊原因,相关数据将不再被处理。如果您对将您的数据用于广告和营销目的提出异议,相关数据将不再用于这些目的。Personal Data Protection Commission (PDPC) 是在 PDPA 第15条意义下的负责机构。

You have the right to obtain information from Personal Data Protection Commission (PDPC) about the personal data stored about you. If the data stored about you is incorrect, you have the right to have it corrected or deleted. If it cannot be determined immediately whether the data is incorrect or correct, you have the right to block the respective data until clarification. If your data is incomplete, you can request that it be completed.

If you have given your consent to the processing of the data stored by Personal Data Protection Commission (PDPC), you have the right to withdraw this consent at any time. The revocation does not affect the legality of the processing of your data carried out on the basis of your consent prior to any revocation.

If you have any objections, requests or complaints regarding data protection, you can contact the data protection officer of Personal Data Protection Commission (PDPC) at any time. He will help you quickly and confidentially in all matters relating to data protection. You can also complain about the processing of data by Personal Data Protection Commission (PDPC) to the data protection officer responsible for your federal state.

The data that Credit Bureau (Singapore) Pte Ltd (CBS) has stored about you comes from publicly accessible sources, from debt collection agencies and from their customers. In order to describe your creditworthiness, Credit Bureau (Singapore) Pte Ltd (CBS) calculates a score for your data. The score value includes data on age and gender, address data and, in some cases, payment experience data. This data is included in the score calculation with different weightings. Credit Bureau (Singapore) Pte Ltd (CBS) customers use the score values as an aid when making their own credit decisions.

Right of objection:

The data stored by Credit Bureau (Singapore) Pte Ltd (CBS) is processed for compelling legitimate reasons of creditor and credit protection, which regularly outweigh your interests, rights and freedoms or serve to assert, exercise or defend legal claims. You can only object to the processing of your data for reasons that arise from your particular situation and must be proven. If such special reasons can be proven, the data will no longer be processed. If you object to the processing of your data for advertising and marketing purposes, the data will no longer be processed for these purposes. Personal Data Protection Commission (PDPC) is responsible within the meaning of Section 15 of the PDPA.

PM-INTERNATIONAL 将您的数据用于以下处理流程：

- 向您发送个性化的优惠和信息，以便满足您的个人兴趣。当然，您也可以选择告知我们，您不希望接收此类优惠和/或信息，或不再希望继续接收它们。我们当然会遵守这一点。请发送电子邮件至我们数据保护官 (DPO) 在第一页上列出的电子邮件地址。

为了通过外部服务提供商交付货物，PM-International 将必要的信息 (收件人、送货地址以及如适用的收货授权人) 提供给这些公司和PM集团成员，以履行合同义务 (《欧盟通用数据保护条例》GDPR第6条第1款第1句b项)。PM-International 不进行任何地址营销。PM-International 与所有符合《欧盟通用数据保护条例》GDPR第28条、第29条要求的外部服务提供商签订数据处理协议。

您可以随时通过点击包裹信息电子邮件末尾的“在此取消订阅”来撤回您的同意。撤回后，我们将删除您为此目的提供的数据，除非您明确同意继续使用您的数据，或者我们保留在法律允许的范围内使用超出此目的的数据的权利，并在本声明中告知您相关信息。

各个订单的数据会保留在该网站的密码保护用户账户中，供相应的客户访问，特别是为了方便客户在订购系统中简单地进行后续订单操作，购买已经购买过的产品。客户可以随时在本网站的用户账户中查看和更改存储在其客户账户中的库存数据以及所选密码——位于“我的数据”部分。

客户可随时通过邮寄、电话或电子邮件的方式，向本声明首页所列的数据保护官 (DPO) 电子邮件地址发送通知，申请删除其客户账户及所有相关数据。在这种情况下，PM-International 将立即删除您所有的客户数据，除非其使用仍然对于处理订单是必要的，或者根据适用法律，PM-International 有义务存储这些数据。然而，在两种情况下，数据将被封锁，并尽快删除。

PM-International uses your data for the following processes:

- To use the information stored in your user profile to offer you the possibilities of a customized service and the optimal use of our website.
- To send you individual offers and information that are of personal interest to you. Of course, you also have the option of informing us that you do not wish to receive such offers and/or information or no longer wish to receive them. We will of course comply with this. Please send an e-mail to the e-mail address of our DPO figuring on the first page.

For the delivery of the goods by external service providers, PM-International passes on the necessary information (recipient, delivery address and, if applicable, persons authorized to receive the goods) to these companies and to members of the PM Group of companies in order to fulfill the contractual obligations (Section 15 of the PDPA (i.e. deemed consent from you)). PM-International does not engage in any address marketing. PM-International concludes data processing agreements with all external service providers that meet the requirements of Regulations 10 and 11 of the Personal Data Protection Regulations 2021.

You can revoke your consent at any time by clicking “unsubscribe here” at the end of a parcel information email. After revocation, we will delete your data provided for this purpose, unless you have expressly consented to further use of your data or we reserve the right to use data beyond this, which is permitted by law and about which we inform you in this declaration.

The data of the individual orders remain accessible in the password-protected user account of this website for the respective customer, in particular to enable follow-up orders of the products already purchased in the ordering system in a simple manner. The customer can view and change the inventory data stored for his customer account as well as the selected password at any time on this website in his user account – there in the “My data” section.

A customer can have their customer account and all associated data deleted at any time by sending a message by mail, telephone or e-mail to the e-mail address of our DPO figuring on the first page. In this case, PM-International will immediately delete all your customer data, unless their use is still necessary for the processing of an order or PM-International is obliged to store them due to applicable law. In both cases, however, the data will be blocked and deleted as soon as possible.

将数据传输给MomentumFactor的目的是确保公平竞争,保护PM-International免受欺诈活动,从而限制PM-International(共同)责任,特别是在涉及禁止的产品声明时。为达成上述目的,MomentumFactor运用自动化程序识别团队合作伙伴违反与PM-International所订立合同协议以及违反竞争法相关法律条文的行为。本数据处理的法律依据为《通用数据保护条例》第6条第1款第1句f项(GDPR)。

For these purposes, MomentumFactor uses automated procedures to identify violations by Team Partners of contractual agreements with PM-International and of statutory provisions in the area of competition law. The legal basis for this data processing is Art. 6 para. 1 sentence 1 lit. f) GDPR.

The data is shared automatically, in a regular cycle, between the PM-International database and MomentumFactor. The services at MomentumFactor are stored in an Amazon Web Services cloud in the USA. The data is deleted from our database in accordance with our deletion procedure and subsequently also from MomentumFactor.

The contractual basis for the transfer of personal data is the service contract and the order processing agreement between PM-International and MomentumFactor. In addition, the data transfer to Momentum Factor is based on the relevant EU standard contractual clauses for the transfer of personal data to third countries. MomentumFactor is compliant (officially certified) according to the GDPR. MomentumFactor’s infrastructure, organization, product and internal security as well as data security and data protection are externally monitored and audited.
